He recently convinced the Chapter 11 trustee of a large bankruptcy case pending in California not to pursue claims against a Virginia business that received allegedly preferential and fraudulent conveyances in excess of \$100,000.00, settled a contentious lease guaranty claim against solvent Chapter 7 debtors, and successfully navigated payment in full of a bank's claim against a real estate developer that was the subject of multiple forbearance agreements over several years.
