EXPERIENCE

- Coordinated multiple IP portfolio licensing campaigns for IP portfolios including: a campaign for frequency and
 protocol agile wireless and cellular devices, which included filing multiple lawsuits in the Eastern District of
 Virginia on behalf of one of the inventors and his company; a campaign relating to leveraging mobile devices for
 mapping of branded locations which included multiple lawsuits in the Northern District of Illinois, and a wide
 range of additional lawsuits filed in federal courts across the country.
